COUNCIL OF MINISTERS REGULATION No.473/2020

COUNCIL OF MINSTERS REGULATION TO PROVIDE FOR THE ESTABLISHMENT OF THE INSTITUTE OF STRATEGIC AFFAIRS

This Regulation is issued by the Council of Ministers pursuant to Article 5 and 34 of the Definition of Powers and Duties of the Executive Organs of the Federal Democratic Republic of Ethiopia Proclamation No.1097/2018.

1. Short Title

This Regulation may be cited as "the Institute of Strategic Affairs Establishment Council of Ministers Regulation No.473/2020."

2. <u>Definition</u>

Unless the context requires otherwise, in this Regulation:

- 1/ "Ministry or Minister" means the Ministry or Minister of Foreign Affairs;
- 2/ "Institute" means the Institute of Strategic Affairs;

- 3/ "Strategic Affairs" means national, regional and global peace, security & stability, state building, nation building, democratization, constitutionalism, social, historical, conceptual, legal, and institutional policy and strategic affairs;
- 4/ any expression in a masculine gender includes the feminine.

3. Establishment

- 1/ The Institute of Strategic Affairs (hereinafter referred to as "the Institute") is here by established as an autonomous Federal government institution having its own legal personality.
- 2/ The Institute shall be accountable to the Ministry.

4. Headquarters

The Institute shall have its headquarters in Addis Ababa and may have branch offices elsewhere, as may be necessary.

5. Objectives of the Institute

The Institute shall have the following objectives:

- 1/ Develop alternative policy options and recommendations through carrying out actionable policy research, studies and analysis; organize seminars, workshops, discussions and lectures based on the country's peace, security and foreign policy and strategy;
- 2/ serve as a center of excellence in research and undertake studies on peace and security, events, threats and trends at national, regional and global levels;

- 4/ conduct awareness raising and skill development trainings that help consolidate peace and stability.

6. Powers and Duties of the Institute

The Institute shall have the following powers and duties:

- 1/ collect and analyze information and undertake research on major national, regional and global issues;
- 2/ conduct studies and research on national peace and security, and foreign policy and strategy and on the implementation of these policies with a view to identify and propose alternative strategies of implementation;
- 3/ provide research and evidence based consultancy on issues of peace and security, national consensus, democratization, foreign policy and other strategic issues;
- 4/ organize short term trainings, seminars, workshops, symposia, conferences and other knowledge and skills exchange and debate platforms on peace and security, democratization and foreign policy;
- 5/ establish partnerships, networks and cooperation and organize joint forums with international organizations, governmental and non-governmental institutions with similar objectives;
- publish and disseminate research and study findings;

- 8/ Undertake other activities necessary to realize its objectives.

7. Organization of the Institute

The Institute shall have:

- An Executive Director and, as may be necessary, Deputy Executive Directors, to be appointed by the Government; and
- 2/ The necessary staff.

8. Powers and Duties of the Executive Director

- 1/ The Executive Director shall be the chief executive officer of the Institute and shall. direct and administer the activities of the Institute.
- 2/ Without prejudice to Sub-Article (1) of this Article, the Executive Director shall in particular:
 - exercise the powers and duties of the Institute provided under Article 6 of this Regulation;
 - b) employ and administer employees of the Institute in accordance to the federal civil service laws;
 - c) prepare and submit to the Council the program of work of the Institute and implement the same as per the Council's recommendation;
 - d) prepare annual budget of the Institute and submit to the Council for advice and implement it upon approval by the government;
 - effect expenditure in accordance with the approved annual plan and budget of the Institute;
 - represent the Institute in its dealings with third parties;
 - prepare and submit to the Council the operational and financial reports of the Institute.

9. Powers and Duties of the Deputy Executive Directors

- 1/ The Deputy Executive Directors shall:
 - a) assist the Executive Director in the implementation of the Institute's powers and duties;
 - b) supervise activities and projects assigned to their respective positions;
 - c) follow up the implementation of the directives and decisions of the Executive Director with respect to their respective positions;
 - d) Perform other activities assigned to them by the Executive Director.
- 2/ In the absence of the Executive Director, the delegated Deputy Executive Director shall lead and coordinate the activities of the Institute

10. Budget

Budget of the Institute shall be allocated by the government.

11. Books of Accounts

- 1/ The Institute shall keep complete and accurate books of accounts.
- 2/ The books of accounts and other financial documents of the Institute shall be audited annually by the Auditor General or by an Auditor designated by the Auditor General.
- 3/ The institute shall have an internal Auditor.

12. Repeal and Inapplicable Laws

1/ The Ethiopian Foreign Relations Strategic Studies Institute Establishment Council of Ministers Regulation No. 347/2015 is hereby repealed. ፪/ ይህን ደንብ የሚቃረኑ ሌሎች ደንቦችና መመሪያዎች በዚህ ደንብ የተሸፊኑ ጉዳዮችን በሚመለከት ተፊፃሚነት አይኖራቸውም፡፡

13. Transfer of Rights and Obligations

The rights and obligations of the Ethiopian Foreign Relations Strategic Studies Institute Established under Regulation No. 347/2015 are hereby transferred to the Institute.

14. Effective Date

This Regulation shall enter into force on the date of publication in the *Federal Negarit Gazette*.
