**6. Organization of the Commission**

The Commission shall have:

1/ a Federal Sports Council (hereinafter "the Council");

2/ a Commissioner and, as may be necessary, Deputy Commissioners appointed by the government; and

3/ the necessary staff.

**8. Meetings of the Council**

1/ The Council shall hold regular meetings twice every year; provided, however, that it may hold an extraordinary meeting whenever necessary.

2/ There shall be a quorum where the majority of the members are present at a meeting of the Council.

3/ Decisions of the Council shall be passed by majority votes; in case of a tie, the Chairperson shall have a casting vote.

4/ Without prejudice to the provisions of this Article, the Council may adopt its own rules of procedure.

**9. Powers and Duties of the Council**

The Council shall have the powers and duties to:

1/ deliberate on and forward proposals for the promotion of sports;

2/ deliberate on and forward recommendations on policy issues to be submitted to the government relating to sports;

3/ approve directives to be issued by the Commission pursuant to Article 5(7) of this Proclamation.

**10. Powers and Duties of the Commissioner**

1/ The Commissioner shall be the chief executive officer of the Commission and, as such, shall direct and administer the activities of the Commission.
