# REGULATION FOR THE AMENDMENT OF NATIONAL TEHADSO COMMISSION ESTABLISHMENT REGULATION

This Regulation is issued by the Council of Ministers pursuant to Article 103 of the Definition of Powers and Duties of the Executive Organs Proclamation No. 1263/2021.

### 1. Short Title

This Regulation may be cited as "The Establishment of National Tehadso Commission Amendment Council of Ministers Regulation No 541/2023"

### 2. Amendment

The establishment of The National Tehadso Commission Council of Ministers Regulation No. 525/2022 is hereby amended as follows:

  - "(፩) ብሔራዊ የተሐድሶ ቦርድ(ከዚህ በኋላ"ቦርድ" ተብሎ የሚጠራ)"
- ፬/ የደንቡ አንቀጽ ፱ ተሰርዞ በሚከተለው አዲስ አንቀጽ ፱ ተተክቷል፤

- ፩/ በደንቡ አንቀጽ ፲ እና ፲፩ ድን*ጋጌዎ*ች ስር "ምክር ቤት" የሚለው ሐረግ ተሰርዞ "ቦርድ" በሚለው ቃል ተተክቷል።

- 1) Article 3 (2) of the Regulation is deleted and the following new Sub Article (2) is added.
- "(2) The Commission shall be accountable to the Ministry of Defense."
- 2) Article 6 (11) of the Regulation is deleted and the following new Sub Article (11) is added:
  - "(11) The Commission may initiate Directives necessary for the effective implementation of this Regulation to be approved by the Board."
- 3) Article 7 (1) of the Regulation is deleted and the following new Sub Article (1) is added.
  - "(1) the National Tehadso Board (hereinafter called "Board.")
- 4) Article 9 is hereby deleted and the following new Article 9 is added:

### "9. Members of the Board

- 1/ The Board shall have members from relevant bodies;
- 2/ Members and the Chairperson of the Board shall be determined by the Prime Minister.
- 3/ The Commissioner of the Commission shall serve as Secretary of the Board."
- 5) The phrase "Council" under the provisions of Articles 10 and 11 of the Regulation is deleted and substituted by the word "Board."
